Opening of public contract formation procedure for the 'Expansion Plan of the Metropolitano de Lisboa - Extension of the Yellow and Green Lines - Rato - Cais do Sodré'

Following the Resolution of the Council of Ministers no. 173 / 2018, of 14th the Metropolitano de Lisboa, E.P.E. hereby announces that it will launch the contract formation procedure for the undertakings relating to the shells works between Rato and Cais do Sodré Station.

Prior to the opening of the procedure, the Metropolitano de Lisboa, E.P.E. intends to carry out a preliminary market consultation for potential economic agents interested in participating in the contract formation procedure, under the terms and for the purposes of the provisions of article 35-A of the Public Contracts Code.

Preliminary market consultation session

An informal consultation session will be held on the market in the auditorium of the Metropolitano de Lisboa, E.P.E., at the Alto dos Moinhos metro station on December 20, 2018, from 10:00 am to 1:00 pm.

The consultation session will be exclusively conducted in the Portuguese language and will be reserved for all economic agents potentially interested in participating in the contract formation procedure referred to above.

Participation in the session must be subject to prior registration to be made until 12:00 pm on December 19th, 2018, through an electronic message addressed to consulta.preliminar@metrolisboa.pt, to which must be attached the respective letter of representation issued by one of the economic agents who shows an interest in participating in the procedure.

Until 5:00 pm on December 19, the Metropolitano de Lisboa, E.P.E. will confirm the registration for the consultation session through a message sent to the electronic address used to present the expression of interest in participating in the preliminary consultation to the market.

Attendance at the pre-market consultation session will not be accepted without confirmation of registration by the Metropolitano de Lisboa, E.P.E ..

Purpose of the preliminary consultation

The Preliminary Consultation is intended to prepare the contract formation procedure and will not have the effect of distorting competition or result in any breach of the principles of non-discrimination and transparency.

The Preliminary Consultation and this document are for information purposes only, not binding the Metropolitano de Lisboa, E.P.E. to this information, so that they may not be considered or accepted in the parts of the contract formation procedure, to be approved by the body competent to take the decision to contract.

Contract modality

The contracts to be celebrated must take the form of contract for design / construction, observing the legal and regulatory provisions inherent to this type of contract.

Type of procedure

The procedure for the formation of the contracts to be adopted shall be the public tender restricted by prior qualification with international publicity.

Batching

In principle, the procedure will be divided into two lots:

Lot 1

It includes the design and execution of the following components:

- Reformulation of the Ventilation Shaft No. 208
- Section 33 (partial)
- Estrela Station
- Section 34

• Ventilation Shaft No. 213

Lot 2

It includes the design and execution of the shells of the following components:

- Santos Station
- Section 35 (partial)
- Ventilation Shaft No. 218
- New west hall at the Cais do Sodré Station

Deadline for procedure and submission of proposals

The estimated term for the conclusion of the procedure will be 6 (six) months, estimated to start in January 2019.

The estimated deadline for submission of applications is 20 (twenty) days from the date of publication of the respective announcement.

The estimated deadline for submission of proposals is 3 (three) months.

Contract deadline

It is estimated that the contract to be concluded will last 36 (thirty-six) months.

The following questions may also be addressed at the consultation session:
